How to Apply for Admission to DDD

Contact the intake office on your island and schedule a meeting with an intake worker.

Intake process can take several months

Includes Assessment and Psychological Evaluation, Medical Reports, Specialist Reports, and Department of Education records review

When to Apply?

Now! DDD provides services to individuals throughout their lifespan. If denied before, the student can apply again.

After admission into DDD, a needs type assessment and an Individualized Service Plan (ISP) will need to be completed. This process can take up to a month.

How to Apply for Direct Service Supports

Once admitted into DDD, the student will automatically get Targeted Case Management. To get additional direct service supports, they must apply and qualify for Medicaid and Medicaid Home and Community Based Waiver Services through the Department of Human Services. This two-step approval process takes a minimum of three months.

With DDD Waiver Services, you can receive **Employment Related Options**: Benefit Counseling, Discovery & Career Planning, Individual Employment Supports, and a direct service worker to assist the student at college (post- secondary education).

Other DDD Waiver Services includes Community Learning Service for other than on-the- job training.

Individualized Educational Program (IEP)

Includes:

Course of Study and Formal Transition Plan (Starting at age 14 or younger)

Formal Transition Plan (Starting at Age 14) Requirements:

- Plan must be coordinated
- Student must be invited
- Parental consent is required to invite agencies & others
- Includes measurable post secondary outcomes in education, employment/ vocational training and independent living.
- Includes annual IEP goals to achieve outcomes
- Includes services provided to achieve outcomes
- Includes agencies of your choice that provide resources and services: like DDD and DVR
- Ongoing or Annual Vocational Assessment

Note on Potentially Eligible Students

Pre-ETS are limited to five services and are available for any student with a disability between the ages of 14-22 (the day before their 22nd birthday): Job Exploration Counseling, Instruction on Self-Advocacy, Work Readiness Training, Work Based Learning Experiences and Counseling on Post- Secondary Educational Opportunities.

The Potentially Eligible student will be limited to only these five services and will complete a simplified application with DVR. If the student needs additional services, they will need to submit the full VR application, be determined eligible and have an approved IPE.

Student Exits DOE

Student can receive DOE services up to the day they turn the age of 22, as long as they remain eligible

Employment Services can be supported by all three agencies DDD, DOE and DVR

These can include: Job search, Job development, Job placement, Job coaching, Vocational training, On-The-Job-Training and Coordination of Natural Supports

Department of Human Services Division of Vocational Rehabilitation (DVR)

Referral and Application (not to exceed 30 days)

DOE and/ or Parent initiates the referral to DVR for Transition Services and Pre-Employment Transition Services (Pre-ETS). DVR Counselor meets with the student, family. and/or transition coordinator for the intake interview. Students will have a choice to initiate DVR services through the Potentially Eligible or VR-eligible application process.

Eligibility Determination (not to exceed 60 days)

DOE must provide assessments and evaluations, which can include, but is not limited to:

- Academic Behavioral
- Cognitive
- Social
- Functional
 - Report Card Summary (diploma track students)
- Vocational

Individualized Plan for Employment (IPE)

(not to exceed 90 days)

The employment goal must be consistent with the student's abilities, capabilities, strengths, resources, priorities, interests, concerns and informed choice. It also reflects services needed to accomplish the employment goal. Includes joint evaluation of the primary employment factors in determining what services and training to provide and mapping what student wants to do after high school.

Department of Education (DOE) Special Education

Special education is specially designed instruction and services to meet the unique needs of students with disabilities. Services under IDEA can include specially designed instruction in academics, speech-language pathology, behavioral health counseling, and physical and occupational therapy. The Department provides IDEA services at no cost to families to students aged 3 to 22, who demonstrate a need for specially designed instruction, after an eligibility determination.

How do I get help for my child?

Contact your child's home school and request an evaluation for Special Education Eligibility. The request can be made by [either]:

- · Verbally, in person, or by phone;
- · In a written letter, faxed, or e-mailed; or
- On the State of Hawai'i Request for Evaluation form obtained from the school.
- · Return the form to the school office.

Frequently Asked Questions

- If a student is receiving 1:1 supports in the school can they still receive DDD Waiver Services? Yes. DDD Waiver Services are not provided during school hours, so it is not a duplication of service.
- Does a student have to be denied DVR services before they can get DDD Waiver Services for employment? No. DDD Waiver Services for employment supports can happen at the same time; however, close coordination with DDD, DVR and DOE must occur to ensure no duplication of services.
- If a student gets a job and gets paid, will they lose all their benefits, like SSI, Medicaid, SNAP? No. Benefit counseling is recommended to assure this does not happen. Also, an Achieving a Better Life Experience (Hawai'i ABLE) account can be set up to protect the students benefits.
- If a student is deemed ineligible for admission into DDD, can they reapply? Yes. It is recommended to reapply in one year.
- If a student was receiving Waiver services in another State, will they automatically be eligible for DDD services in Hawai'i?
 No. They must apply when they arrive to Hawai'i and meet Hawai'i's eligibility criteria.
